9th - Class of 2024	22 credits + 3 interims





Policy Update

- 1) Science flexibility (Admin Guideline Policy 5460)
 - a) Modify science requirements to Chemistry OR Physics/Physical Science
 - i) Important for our kids who attend KCTC or have Encore classes to meet their IEP requirements
 - ii) Creates flexibility they can meet their 3rd science requirement at KCTC, most likely.
 - b) Application of equivalency credits for CTE programs & courses
- 2) PE flexibility
