## **Recurring Grants**

- Title I, II, III, IV (\$267,741)
- 31a At-Risk (\$911,249)
- IDEA Special Education (\$1,140,533)

Funding source is predictable, allocations vary year by year based on eligible students. Allocations reflected here are for 22/23.

## **One-Time Funding**

- Covid-Related Grants
  - \$10 million over 4 years
  - March 2020 to Sept 2024
- Planned Expense for 22/23
  - ESSER II (\$728,860)
  - ESSER III (\$1,619,187)
  - ESSER 11t (\$2,002,592)

Funding source is one-time and must all be spent by Sept. 2024.
